Camping Rules

****Please read all rules carefully****

- 1) Reservation must be received by October 19th.
- 2) Price is \$30.00 per night.
- 3) Completed registration form, including check or money order must be mailed to: Wyoming County Community Fair - halloWINEfest, C/O Marjorie Singer, 504 Dunlop Road, Meshoppen, PA 18630.
- 4) Incomplete forms will be returned.
- 5) All camper spots will be assigned on a first come, first serve basis. You must take your assigned spot.
- 6) Measure the overall length of your camper including your hitch. Measure accurately, if you do not fit in your assigned spot, you will be placed in the next available space that best fits your camper.
- 7) Campers may not enter the grounds until Friday, October 28th at 4pm and must be checked out by Sunday, October 30th at 4pm.
- 8) Please DO NOT put your awning up until your neighbor is in their spot.
- 9) Campers are responsible for blocking and electrical cords. Note: Water hook ups are NOT available behind the Ag barns and there is NO sewer hook ups in any of the camping areas.
- 10) Camping Permits can be picked up in the office and must be displayed prominently at all times during the Fair.
- 11) All campers are required to have an operational fire extinguisher.
- 12) This is a 21 & OLDER event, no one under the age of 21 is allowed on the property.
- 13) All guests must be checked into the office prior to spending the night.
- 14) No dumping of grey water or other waste on property.
- 15) **NO AIR CONDITIONERS!** If you wish to run your air conditioner you must have your own generator.
- 16) Generators must be shut off between the hours of 10:00 PM and 7:00 AM - Please be considerate to your neighbors.
- 17) All campers must be removed from the grounds by 4:00pm Sunday, October 30th.
- 18) Assigned camping area must be cleared of all items before leaving the grounds, failure to do so will result in not being allowed back next year.

The Wyoming County Community Fair and their members will not be responsible for any accident or any kind or nature that may occur to any animal, person or property. All patrons shall hold them harmless and indemnify them against any legal proceeding arising from any accident and/or damage. By submitting your camper registration to the Wyoming County Community Fair you agree to abide by these rules as well as any rules posted before or during the Fair.
